World Trade Centre, Goa, in association with the Ministry of Finance, Govt. of India organized a Work Shop on "E-Way Bill" on 27th February, 2018,at Margao, Goa.

Mr Gaurav Kumar Jain, IRS, Assistant Commissioner, GST, Ministry of Finance, Government of India who was the main facilitator for the workshop, explained the concept of e-way bill that it is an electronic document generated on the GST portal evidencing movement of goods. It has two Components-Part A comprising of details of GSTIN of recipient, place of delivery (PIN Code), invoice or challan number and date, value of goods, HSN code, transport document number (Goods Receipt Number or Railway Receipt Number or Airway Bill Number or Bill of Lading Number) and reasons for transportation; and Part B comprising of transporter details (Vehicle number)....<u>More Details</u>

# Know the Entrepreneur



Mr. Shibhu Reghunathan Proprietor, Shib's Media Plus

They say that successful Entrepreneurs are not born in the profession but painstakingly with their Grit, hard work and dedication that make a mark for themselves to be titled so in the business world.

One such interesting journey is that of Mr Shibhu Reghunathan, who until he was 23 to 24 years old faced only hardships and setbacks. He says that this was the most bitter life experience and the blackest days of his life. His misfortune was such that he sometimes went to bed without having a single meal, he learnt the toughest lessons for life. This situation instilled in him the determination to make something for his life as he was clearly not born with a Silver Spoon.

He moved from his early years in Kerala and travelled to Goa, a land that he soon liked and wanted to call his home and started taking hands on technical training in Graphic Designing and Photography. He then offered his services

to different advertising agencies in Goa and won laurels for the work that he created. At this time too Mr Shibhu helped his friends by doing free lancing for them through which he helped their business to grow and also won for himself their confidence.

Mr Shibhu at this stage in his life, had managed to create a good bunch of friends and colleagues who impressed with his creativity, urged and encouraged him to set up his own business. He seriously evaluated their suggestions and with a miniscule assured business he took the challenge and started his own informal business, with the setting up of a small scale printing workshop and with his hard work and determination his business began to prosper.

"Be honest, sincere and Work hard" was the motto he coined for himself and this stood him in good stead and made his business flourish. Buoyed by his success he in the year 2005 plunged into the formal business sector, registered his firm and made it complaint with all the Government mandated rules and regulations and started "Shib's Media Plus", a fully fledged firm specializing in creating, designing, printing and supply of promotional and advertising material that spanned the entire state of Goa and neighboring town of Kolhapur. He also supplied fine imported paper of the "kyoorius" brand to this region and side by side promoted another firm S R Enterprises which specialized in Printing, supply of stationery and channelized the supply of the imported fine paper vertical. He then went on to successfully launch D & P Combines for Printing and Stationery supplies. He has now since the last 10 to 15 years been concentrating on the Tourism and Hospitality sector and this high growth sector has also gifted him with excellent business growth.

The stupendous growth that he achieved, he attributed to the society in which he lived in and who supported him whole heartedly and he thus felt a Moral Responsibility to give back something back to this society and he took part in many voluntary acts that helped him strengthen this society. He dedicated a good amount of his time for the Rotary International, as Chartered Member of the Rotary Club of Margao Midtown, where his work as the club's President won for them the maximum number of awards in the year 2012-2013. He served as the India Regional President for the World Malayali Council and was recognized for his good leadership qualities and astute administrative acumen. Mr Shibu is also associated with the Indian Red Cross society , as its Paton member and Chairman of its Salcette branch. He volunteered his services for the Nepal Earth quake relief mission. He served the International Human Rights society as the General Secretary of the Goa State .
